## ARTICLES OF ORGANIZATION

#### OF

Name. The name of this limited liability company is Miroplex Properties, L.L.C., a Florida limited liability company (the "Company").

- 2. Duration. The Company shall have perpetual existence, commencing upon the date of filing of these Articles with the Florida Department of State
