ARTICLE I

The name of the Limited Liability Company is "Essilor International Employee, L.L.C."

ARTICLE II

The mailing address and street address of the principal office of the Limited Liability Company is 2400 118th Ave. N., St. Petersburg, Florida 33716.

ARTICLE III

The name and Florida street address of the registered agent are CT Corporation System, 1200 S. Pine Island Road, Plantation, Florida 33324.
