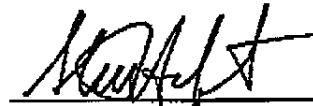
ARTICLE VI - REGULATIONS

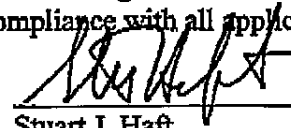
