## ARTICLES OF AMENDMENT

## TO ARTICLES OF ORGANIZATION OF

## RICHLAND TOWERS - INDIANAPOLIS, LLC

THE UNDERSIGNED hereby executes and swears to these Articles of Amendment to Articles of Organization of RICHLAND TOWERS - INDIANAPOLIS, LLC, a Florida limited liability company (the "Company"), pursuant to the Florida Limited Liability Company Act, as amended, *Florida Statutes* § 608.411:
