ARTICLES OF ORGANIZATION
BAYOU BUDDIES, LLC

The undersigned subscribers, hereby form a limited liability company under the laws of the State of Florida, Florida Statutes, Chapter 608 as follows:

ARTICLE I
NAME

The name of this limited liability company shall be BAYOU BUDDIES, LLC.

DURATION

PURPOSE AND POWERS

DISSOLUTION



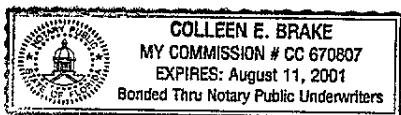


