## ARTICLES OF ORGANIZATION OF NOT A VICTIM, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

### ARTICLE I

The name of the limited liability company shall be NOT A VICTIM, LLC ("Company").

### ARTICLE II ADDRESS

The mailing address and street address of the principal office of the company shall be 4927 Southfork Drive, Lakeland, Florida 33813.

### ARTICLE III DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is earlier dissolved as provided in these articles of organization.

### ARTICLE IV REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the company in the State of Florida is: Jon H. Anderson, Esquire, Anderson & Artigliere, P.A., Post Office Drawer 6839, 4927 Southfork Drive, Lakeland, Florida 33813.

#### ARTICLE V MEMBERS

The company shall have two categories of membership with the following rights and responsibilities:

A. Charter Members. The persons named in Article X and persons subsequently granted status as Charter Members in accordance with Article VIII shall be the Charter Members of the company. Charter Members shall have exclusive control of the company, to the exclusion of all other categories of membership, and shall have such rights, powers and duties as the Charter Members may set forth in the company's regulations.

- B. Associate Members. Associate Members are persons who are afforded that status by the company after complying with the company's requirements for Associate Membership. Associate Members shall have only those rights, powers and duties granted by the company in the company's regulations. The company reserves the right to change or terminate any Associate Member's status as such at any time with or without cause. The company reserves the right to alter, amend or eliminate the rights, powers and duties of Associate Members by amendment of the company's regulations at any time.
- C. Subscribers. Subscribers are persons who subscribe to the company's web site from time to time. Subscribers are not members of the company, and have no rights, powers or duties other than the privilege to enjoy the services the company makes available through its web site from time to time. The company reserves the right to change or terminate any Subscriber's status as such at any time with or without cause. The company reserves the right to terminate any Subscriber's access to the company's web site and web based services at any time, with or without advance notice, and with or without cause. The company reserves the right to limit the privileges of Subscribers in any way at any time.
- D. Other Categories of Membership. The Charter Members may, by the affirmative vote of two thirds of their number, create other categories of membership from time to time. When creating other categories of membership, the Charter Members shall set forth the rights, powers and duties in an amendment to the company's regulations.

### ARTICLE VI CAPITAL CONTRIBUTIONS

Each Charter Member of the company shall contribute ten dollars (\$10.00) to the capital of the company as a capital contribution within thirty (30) days of the filing of these Articles of Organization.

### ARTICLE VII ADDITIONAL CAPITAL CONTRIBUTIONS

Each Charter Member shall make additional capital contributions to the company if required by the unanimous written consent or unanimous vote of all Charter Members.

### ARTICLE VIII ADMISSION OF NEW CHARTER MEMBERS

No additional Charter Members shall be admitted to the company except with the unanimous written consent or unanimous vote of all the Charter Members of the company and on such terms and conditions as shall be determined by all the Charter Members. A Charter Member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a Charter Member

unless all the other Charter Members of the company other than the Charter Member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent or unanimous vote.

### ARTICLE IX TERMINATION OF EXISTENCE

The company shall have perpetual existence, and shall not automatically be dissolved on the death, bankruptcy, or dissolution of a Charter Member or manager, or on the occurrence of any other event that terminates the continued membership of a Charter Member in the company.

### ARTICLE X MANAGEMENT

The company shall be managed by the Charter Members in accordance with regulations adopted by the Charter Members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
