**ARTICLE I  
NAME**

The name of the limited liability company shall be Designs by Wendy, L.L.C.

**ARTICLE II  
MAILING AND STREET ADDRESS**

The mailing address and the street address of the limited liability company is 4345 East Tradewinds Avenue, Lauderdale by the Sea, Florida 33308. 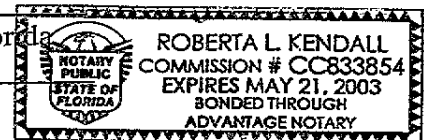
