## ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

### ARTICLE I - Name:

(a) to execute and deliver (i) one or more purchase and sale agreement(s) (the "Purchase Agreements") pursuant to which certain motor vehicle retail financing agreements, furniture financing agreements, credit card receivables, motor vehicle parts and motor vehicle, equipment leasing agreements, and home improvement loan agreements (the "Receivables"), the security interest in such motor vehicles, motor vehicle parts, credit card accounts, furniture, equipment, and home improvements financed thereby ("Financed Goods"), and certain related rights will be purchased and sold (collectively, "Conveyed Property"), (ii) a Master Loan and Security Agreement (the "Loan Agreement") pursuant to which the Conveyed Property will be pledged to the holder of certain notes (the "Notes") made pursuant to the Loan Agreement, (iii) a servicing Agreement(s) (the "Servicing Agreement(s)") pursuant to which the Receivables will be serviced and (iv) such other documents as are necessary or advisable for the Company to undertake all rights, duties and obligations contained in the Purchase Agreements, the Loan Agreement and the Servicing Agreements (collectively referred to herein as the "Agreements")

(b) to perform the functions and obligations pursuant to the Agreements and foregoing documents necessary or desirable to effectuate the foregoing, and to perform such other
