

**ARTICLES OF ORGANIZATION**  
**OF**  
**FULL PLATE**

The undersigned, pursuant to the provisions of Chapter 608, Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida, sets forth the following:

1. Name.

The name of the limited liability company ("Limited Liability Company") is: **Full Plate Hospitality Properties, L.L.C.**

2. Purpose and Duration.

The purpose for which the Limited Liability Company is organized is to engage in all businesses and activities permitted by the laws of the State of Florida. The power to adopt, alter, amend or repeal the regulations of the Limited Liability Company shall be vested in the members of the Company.



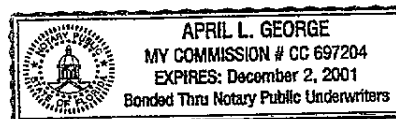
