
ARTICLE V





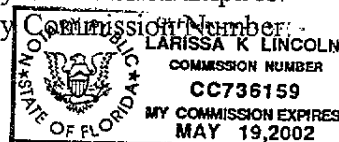
