ARTICLES OF ORGANIZATION
OF
RTAS TECHNICAL SERVICES, L.L.C.

The undersigned person hereby adopts these Articles of Organization in order to form a limited liability company under Chapter 608 of the Florida Statutes.

ARTICLE I - NAME

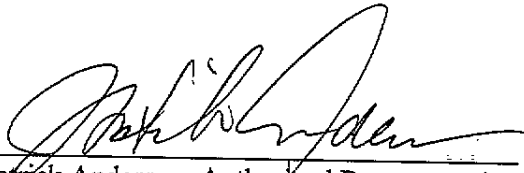
ARTICLE VII - ADOPTION OF OPERATING AGREEMENT

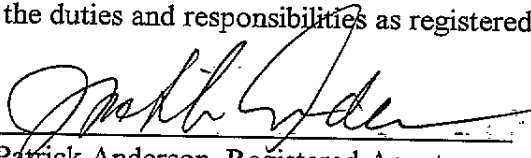
ARTICLE VIII - AMENDMENT
