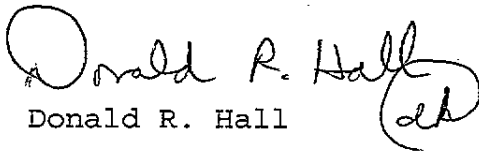

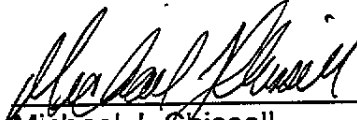
ARTICLE II
