## ARTICLES OF ORGANIZATION

OF

## Dental Defense Specialists, L.C.

The undersigned person, acting hereby as Organizer for the purpose of forming a limited liability company under the Florida Statutes, Chapter 608, hereby executes the following Articles of Organization.

- I NAME. The name of the limited liability company shall be: **Dental Defense** Specialists, L.C. ("Company").
- II ADDRESS. The mailing address and street address of the principal office of the Company shall be 3100 SW College Road #102, Ocala, Florida 34474.
