ARTICLES OF ORGANIZATION

OF

ST. AUGUSTINE IMAGING, P.L.

A Florida professional service limited liability company

ARTICLE 1

NAME

The name of this professional service limited liability company is: St. Augustine Imaging, P.L.

ARTICLE 2

DURATION

The duration of this professional service limited liability company is perpetual. The date and time of commencement of the company existence is the time of filing of the Articles of Organization by the Department of State of the State of Florida.

ARTICLE 3

PURPOSES

The purposes for which this professional service limited liability company is initially organized are to engage in every phase and aspect of the general practice of medicine, rendering the same professional services to the public that a doctor of medicine, duly licensed under Florida laws is authorized to render, but such services will be rendered only through this professional service limited liability company's officers, employees, and agents who are duly authorized under Florida laws to practice medicine. This professional service limited liability company also may engage in any or all lawful business which professional service limited

liability companies practicing medicine may engage in under the Florida Professional Service Corporation and Limited Liability Company Act.

ARTICLE 4

PRINCIPAL AND MAILING OFFICE AND REGISTERED AGENT

TRANSACTIONS IN WHICH MEMBERS ARE INTERESTED

No contract or other transaction between the professional service limited liability company and any other professional service limited liability company, association, person or firm, in the absence of fraud, shall be affected, invalid, void or voidable because one or more members of the professional service limited liability company is or are interested in such contract or transaction as a member of the other professional service limited liability company

or association or otherwise interested in or individually or jointly a party to any contract or transaction of this professional service limited liability company or in which this professional service limited liability company is interested and no member of this professional service limited liability company shall incur any liability by reason of the fact that he is or may be interested in such contract or transaction. A member of the professional service limited liability company may vote upon any such contract or other transaction of the professional service limited liability company and may also vote upon any contract or other transaction between the professional service limited liability company, and any subsidiary or firm without regard to the fact that he is also a member of such subsidiary, controlled, affiliated or other professional service limited liability company, association or firm, and the presence at any meeting of the member may be counted in order to determine the presence of a quorum.

ARTICLE 7

DISQUALIFICATION OF MEMBERS, OFFICERS, AGENTS AND EMPLOYEES

If any officer, member, agent or employee of this professional service limited liability company who has been rendering professional medical services to the public, becomes legally disqualified to render such services within the State or accepts employment which, pursuant to existing laws, places restrictions or limitations upon his continued rendering of such professional services, he shall sever all employment with, and financial interest in, this professional service limited liability company forthwith.

ARTICLE 8

VOTING TRUSTS

No member of this professional service limited liability company shall enter into a voting trust agreement or any other type of agreement vesting in another person the authority to exercise the voting power of any or all of his membership interest.

ARTICLE 9

MEMBERS

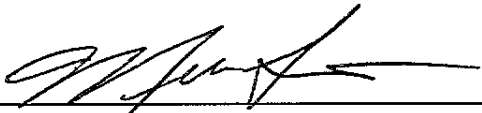

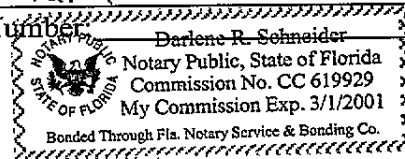
