The name of the Company is **Solutions Interactive, L.L.C.**

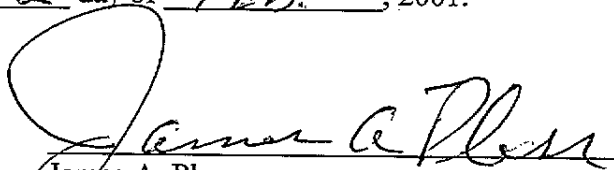
ARTICLE II – DATE OF FILING
