# ARTICLES OF ORGANIZATION OF SOUTHERN MARSH GOLF CLUB, L.C.

The undersigned, being authorized to execute and file these Articles of Organization, hereby certify that:

### **ARTICLE I — Name:**

The name of the limited liability company is "Southern Marsh Golf Club, L.C." (hereinafter referred to as the "Limited Liability Company").

### ARTICLE II — Address:
