ARTICLES OF ORGANIZATION OF COULTER CONSTRUCTION MANAGEMENT, L.L.C.

ARTICLE I PREAMBLE; FORMATION

The undersigned agrees to form, and hereby forms, a limited liability company under the laws of the State of Florida providing for the formation, rights, privileges, and immunities of limited liability companies for profit; and furthermore, declares the following Articles shall serve as the charter and authority for the conduct of the business of the limited liability company.

ARTICLE II NAME; PRINCIPAL PLACE OF BUSINESS; AND INITIAL REGISTERED AGENT

- 2.1 Name. The name of this limited liability company shall be Coulter Construction Management, L.L.C.

- 4.4 To enter into and make all necessary contracts for its business with any person, entity, partnership, association, corporation, domestic or foreign, or of any domestic or foreign state, government, or governmental authority, or of any political or administrative subdivision, or department thereof, and to perform and carry out, assign, cancel, or rescind any of such contracts.
- 4.5 To exercise all or any of the limited liability company powers, and to carry out all or any of the purpose enumerated in these Articles and otherwise granted or permitted by law, while acting as agent, nominee, or attorney-in-fact for any persons or corporations, and perform any service under contract or otherwise for any corporation, joint stock company, association, partnership, firm, syndicate, individual, or other entity, and in such capacity or under this arrangement develop, improve, stabilize, strengthen, or extend the property and commercial interest of the property; and to aid, assist, or participate in any lawful enterprise in connection therewith or incidental to the agency, representation, or service, and to render any other service or assistance it may lawfully do under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit.
- 4.6 To do everything necessary, proper, advisable, or convenient for the accomplishment of any of the purposes, or the attainment of any of the objects, or the furtherance of any of the powers set forth in these Articles, either alone or in association with others incidental or pertaining to, or going out of, or connected with its business or powers, provided the same shall not be inconsistent with the laws of the State of Florida.
