**ARTICLES OF ORGANIZATION
OF
ANDALUSIA HOMES, L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I
Name

The name of the Limited Liability Company shall be ANDALUSIA HOMES, L.L.C. ("Company").

ARTICLE II
Address

The mailing address and street address of the principal office of the Company is 2320 First Street, Suite 1000, Fort Myers, Florida 33901, Attention: Steven W. Hubbard.

ARTICLE III
Commencement and Term of Existence

In accordance with Section 608.409(1) of the Florida Limited Liability Company Act (the "Act"), the term of existence of the Company shall commence upon filing and shall continue until December 31, 2045, unless otherwise dissolved pursuant to Article VIII of these Articles of Organization.

ARTICLE IV
Registered Office and Agent

The name and street address of the registered agent of the Company in the State of Florida is Steven W. Hubbard, Roetzel & Andress, a Legal Professional Association, 2320 First Street, Suite 1000, Fort Myers, Florida 33901.

ARTICLE V
Initial Capital Contributions

The member(s) of the Company shall make initial contributions to the capital of the Company in the aggregate amount of \$1,000.00.

ARTICLE VI
Additional Capital Contributions

Each member shall make additional future capital contributions to the Company as provided in the Regulations of the Company or otherwise by the unanimous consent of all the members.

ARTICLE VII
Admission of New Members

No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and on such terms and conditions as shall be determined by all the members. A member may only transfer his or her interest in the Company as set forth in the Regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company, other than the member proposing to dispose of his or her interest, approve of the proposed transfer by unanimous written consent.

ARTICLE VIII
Dissolution of Company

Upon the death, insanity, bankruptcy or dissolution of a member or upon the occurrence of any other event provided in the Regulations of the Company or under the Act, the Company shall be dissolved unless the members elect to continue the Company either upon the affirmative vote or written consent of those members owning a majority of the capital and profits of the Company as contemplated in Rev. Proc. 94-46.

ARTICLE IX
Management

The Company shall be a manager-managed company. The Company shall be managed by the manager or managers elected or appointed by the members in accordance with the Regulations to be adopted by the members for the management of the business and affairs of the Company. These Regulations may contain any provision for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.

ARTICLE X
Amendment

These Articles of Organization may be amended by consent of all members, or as may otherwise be provided by law.
