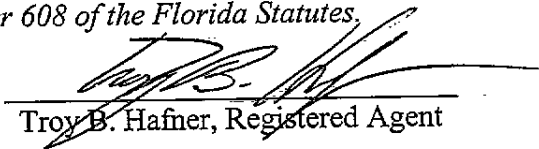

The Managers shall be elected annually in the manner prescribed in the Operating Agreement for this Limited Liability Company.

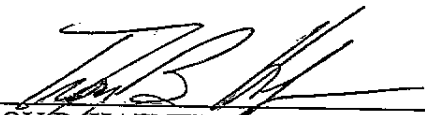
**ARTICLE V -- GOVERNED BY OPERATING AGREEMENT**

These Articles of Organization shall be effective upon the date of filing.

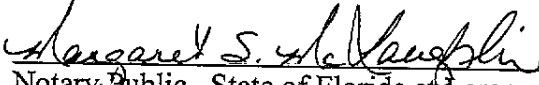
