The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I — Name

The name of the limited liability company (hereinafter referred to as the "Company") is "Ransome Family Partners, LLC".

The Company is to be managed by the members.


ARTICLE VI — Limitation on Agency Authority of Members


