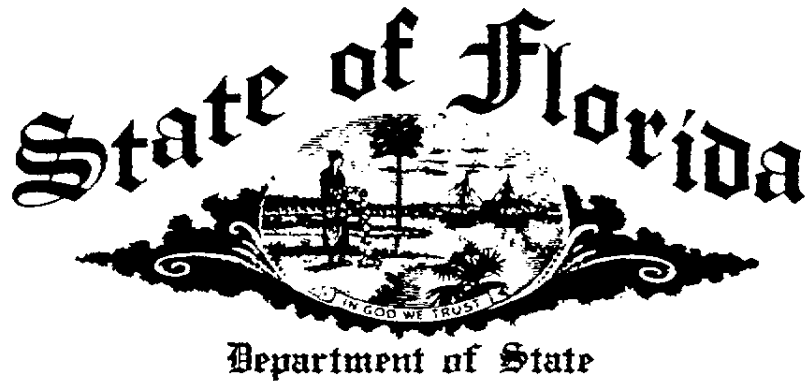

CERTIFICATE OF ADMINISTRATIVE DISSOLUTION


