## ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF SMYERS GOLF, LLC

THE UNDERSIGNED hereby executes and swears to these Articles of Amendment to Articles of Organization of SMYERS GOLF, LLC, a Florida limited liability company (the "Company"), pursuant to the Florida Limited Liability Company Act, as amended, *Florida Statutes* § 608.411:

- 1. Name of Company. The name of the Company is SMYERS GOLF, LLC.
