

## **ARTICLES OF ORGANIZATION OF BULLOCK FARMS, L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

### **ARTICLE I -- NAME**

### **ARTICLE V -- TERMINATION OF EXISTENCE**






