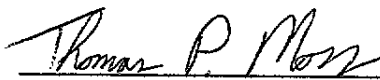

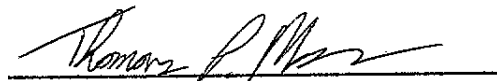
**ARTICLE IV

EFFECTIVE DATE OF ORGANIZATION**

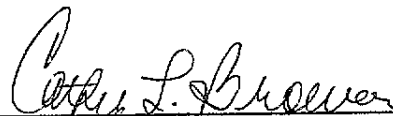
