#### ARTICLES OF ORGANIZATION FOR OPEN MRI OF SANFORD, L.L.C.

#### A FLORIDA LIMITED LIABILITY COMPANY

The undersigned (the "Members") acting as the organizers and the Members of OPEN MRI OF SANFORD, L.L.C., under the Florida Limited Liability Company Act, Chapter 608, Flar Stat., adopt the following Articles of Organization:

#### ARTICLE I NAME

The name of the limited liability company is OPEN MRI OF SANFORD, L.L.C.

## ARTICLE II PURPOSE AND POWERS

- A. <u>Purposes</u>. The Company is organized for the purpose of the operation and management of a medical clinic in Sanford, Florida, providing MRI and other medical imaging services to patients in the Sanford area and for purposes incident thereto, and for no other purposes.
- B. <u>Powers</u>. The Company shall have and may exercise all powers and rights which a limited liability company may exercise pursuant to Chapter 608, <u>Fla. Stat.</u>, as the same may be amended from time to time.

## ARTICLE III INITIAL REGISTERED AGENT, REGISTERED OFFICE ADDRESS

The street address and mailing address of the initial corporate office and initial registered office of this Company is 303 W. First Street, Sanford, Florida 32771, and the name of the initial registered agent of this Company at that address is Keith Freudenberger.

#### ARTICLE IV DURATION

The Company's existence shall commence upon the acceptance of these Articles of Organization by the Secretary of State, and it shall exist perpetually thereafter unless dissolved according to law or the Company's Operating Agreement.

#### ARTICLE V MANAGEMENT

The Company shall be managed by one or more managers as provided in the Company's Operating Agreement.

# ARTICLE VIII AMENDMENTS

The Company reserves the right to amend any provision of these Articles of Organization, which amendment shall only be effectuated by the unanimous written approval of all Members of the Company.
