ARTICLES OF ORGANIZATION OF SUNSHINE INVESTMENTS OF FLORIDA, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization:

ARTICLE I.

NAME OF LIMITED LIABILITY COMPANY
