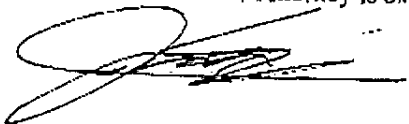

LIMITED POWER OF ATTORNEY

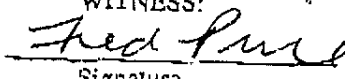
