SIXTH: To the extent applicable, any remaining property and assets of the Company have been distributed among the Company's members in accordance with their respective rights and interests.

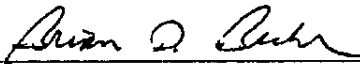
SEVENTH: There are no suits pending against the Company in any court.
