
ARTICLE XII - AMENDMENT

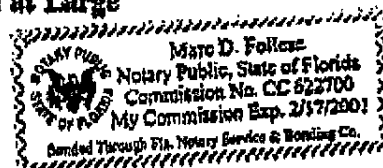



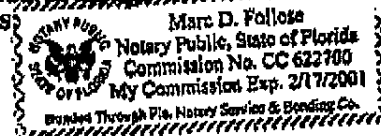
