ARTICLES OF ORGANIZATION

POGGE ENVIRONMENTAL SERVICES, LLC

ARTICLE ONE - NAME

The name of the Limited Liability Company is Pogge Environmental Services, LLC.

ARTICLE TWO - ADDRESS

ARTICLE THREE - DURATION

Pogge Environmental Services, LLC is organized to continue in business in perpetuity.

ARTICLE FOUR - MANAGEMENT/OWNERSHIP

ARTICLE FIVE - ADMISSION OF NEW MEMBERS


New members may be admitted and be issued some or all of the ownership interest held by one of the members. New members may only be added upon the written consent of all Managing Members. Unanimous consent of all Managing Members would also have to be reached regarding the management rights of any new members.

ARTICLE SIX - RIGHT TO CONTINUE BUSINESS

If, due to death, retirement, resignation, or for any other reason a Managing Member must terminate his membership, the remaining Managing Members may continue in business upon their mutual consent. The inability of a non-managing member to continue his/her membership due to death, retirement, resignation or any other reason shall not impair the ability of Pogge Environmental Services, LLC to continue in business.

ARTICLE SEVEN - DISTRIBUTION OF PROFITS/LOSSES

The profits and/or losses of Pogge Environmental Services, LLC must not necessarily be distributed at any regular interval. It is only upon the unanimous agreement of the Managing Membetrs that profits or losses will be distributed. Such profits or losses are to be allocated on the basis of the member's ownership share.


CERTIFICATE OF DESIGNATION OF
