**ARTICLES OF ORGANIZATION  
OF  
SOUTH FLORIDA REFERRAL NETWORK, LLC**

The undersigned members hereby certify that they have associated themselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. **ARTICLE I**

**ARTICLE III**

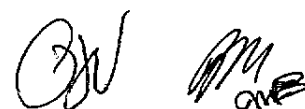
**REGISTERED AGENT**
