ARTICLE IV. - MANAGEMENT

ARTICLE V. - DURATION

The Company's existence shall be perpetual unless the Company is earlier dissolved as provided by the Florida Limited Liability Company Act and the CASH & CROWN FINANCIAL ADVISORS, L.C. Regulations.

ARTICLE VI. - ADMISSION OF ADDITIONAL MEMBERS

The right of the members to admit additional members, and the terms and conditions of such admissions, shall be made by unanimous agreement of all members.

ARTICLE VII. - MEMBERS' RIGHTS TO CONTINUE BUSINESS

The right of the remaining members of CASH & CROWN FINANCIAL ADVISORS, L.C., to continue the business on the death, retirement, resignation, expulsion, or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in the limited liability company, shall be as follows:

The members of CASH & CROWN FINANCIAL ADVISORS, L.C., agree that the Company shall not automatically dissolve upon the death, retirement, resignation, expulsion, or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in the limited liability company. In the alternative, the remaining members shall vote to determine whether to continue the business when a member leaves. The business of the limited liability company shall continue as before if the consent of all the remaining members is given as provided below, thereby dispensing with the need to dissolve and wind-up the business.

CASH & CROWN FINANCIAL ADVISORS, L.C. shall continue, despite the dissociation of any member, if consent is given by:

(1) The remaining members holding a majority of the sharing ratios of all the remaining members. This determination shall be based on a reasonable estimate of profits from the date of the dissolution to the projected termination of the limited liability company, taking into account present and future allocations of profits under the Regulations that are in effect as of the date of the dissociation event; and

(2) The remaining members holding a majority of the capital accounts of all of the remaining members. This determination shall be made as of the date of the dissociation.

The rights of the members expressed herein are intended to conform with Section 608.441(1)(c), Florida Statutes.
