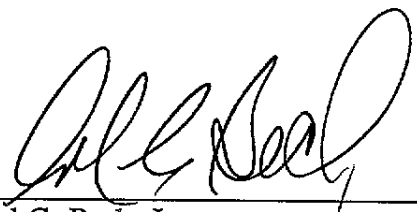

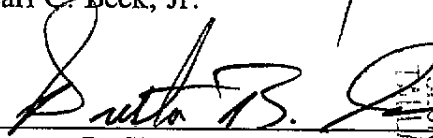

Putnam and State of Florida, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

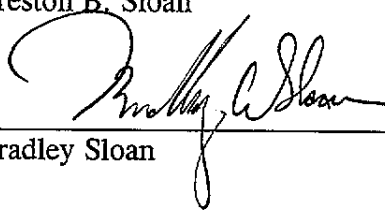

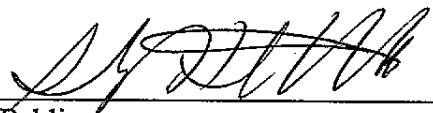
