**ARTICLES OF ORGANIZATION
OF
AVZ ENTERPRISES L.L.C.**

The undersigned hereby forms and establishes a limited liability company pursuant to Chapter 608, Florida Statutes as follows:

ARTICLE I

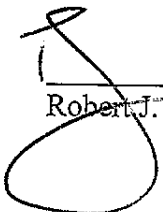
