ARTICLES OF ORGANIZATION OF CORVETTE, L. L. C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, does hereby adopt the following Articles of Organization:

ARTICLE I NAME

The name of the Corporation is: CORVETTE, L. L. C.

ARTICLE II DURATION

The duration of the Corporation is perpetual, unless terminated by the unanimous written agreement of all members or by the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminates the continued membership or a member, unless the business of the company is continued by the consent of the remaining members, or by amendment of the Articles of Organization providing for confinued existence of the company subsequent to the foregoing events.

ARTICLE III ADDRESS

ARTICLE IV INITIAL REGISTERED OFFICE AND AGENT

ARTICLE V ADMISSION OF ADDITIONAL MEMBERS

Additional Members may be admitted upon the approval of a majority of the Members of the Company, upon the written application of such new Member, in the manner set forth in the Regulations of the Company.

ARTICLE VI RIGHT TO CONTINUE BUSINESS

The remaining members may continue the business upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company.

ARTICLE VII MANAGEMENT OF COMPANY

ARTICLE VIII AMENDMENT

Any amendment to this Articles of Organization shall be on such form(s) as prescribed by the Secretary of State of the State of Florida containing such terms and provisions consisted with Florida Statute 608 as shall be prescribed by the Department of State, and shall be signed and sworn to by all Members of the Company. In the event a new Member is added by such amendment, it shall also be signed by the Member to be added.

ARTICLE IX INDEMNIFICATION

The Company shall indemnify each Manager or Member, including former Manager(s) or Member(s), to the full extent permitted by law.

ARTICLE X REGULATIONS OF COMPANY

The power to adopt, alter, amend and repeal the Regulations of the limited liability company shall be vested in the Members, unless vested in the Manager(s) of the company by any amendments of the Articles of Organization. Regulations adopted by the Members or by the Manager(s) may be repealed or altered, new Regulations may be adopted by the Members, and the Members may prescribe in any Regulations made by them that such Regulations may not be altered, amended or repealed by the Manager(s).

ARTICLE XI INFORMAL ACTION OF MEMBERS

Any action of the Member(s) may be taken without a meeting if consent in writing setting forth the action so taken shall be signed by all Member(s) who would be entitled to vote upon such action at a meeting and filed with the Manager(s) of the Company as part of its records.

ARTICLE XII CONTRACTING DEBT

Except as otherwise provided by law, no debt shall be contracted nor liability incurred by or on behalf of this company except by the Manager(s) or if managed by the Member(s), by any Member of this Company unless otherwise provided herein.

ARTICLE XIII TRANSFERABILITY

An interest of a Member of this Company may be transferred or assigned to such extent and in the manner provided in the Operating Agreement. However, if all of the remaining Members of this Company do not approve of such proposed transfer or assignment by unaniforms written consent, the transferee of the interest of such member shall have no right to participate in the management of the business and affairs of the Company or to become a Member The transferee shall be entitled to receive only the share of profits or other compensation by way of income, and the return of contributions to which that Member otherwise would be entitled.

ARTICLE XIV WITHDRAWAL OR REDUCTION OF MEMBERS' CONTRIBUTIONS TO CAPITAL

- A Member shall not receive out of the Company any part of his, hers or its contribution to capital until:
 - (A) all liabilities of the Company, except liabilities to Members on account of their contributions to capital, have been paid or sufficient property of the company remains to pay them,
 - (B) the consent of all Members is had, unless the return of the contributions to capital repayment be rightfully demanded,
 - (C) these Articles of Organization are canceled or so amended as to set out the withdrawal reduction.
- A Member shall be entitled to the return of his, her or its contribution in the manner provided for in the Regulations of the company.
