ARTICLES OF ORGANIZATION OF RENOVATIONS USA, LLC

ARTICLE I Name

The name of the limited liability company is Renovations USA, LLC (hereinafter called the "Company").

ARTICLE II Duration

The existence of the Company shall be perpetual.
