ARTICLES OF ORGANIZATION

OF

WISDOM AVIATION, L.C.

The undersigned, for the purpose of forming a limited liability company the Florida Limited Liability Company Act, Florida Statutes Chapter 608, heavy makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME
