**CONTINUATION OF BUSINESS**

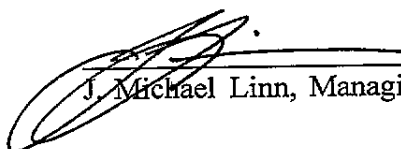

**ARTICLE 6**

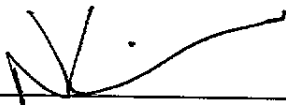
**ADMISSION OF ADDITIONAL MEMBERS**

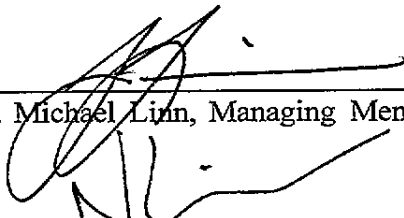

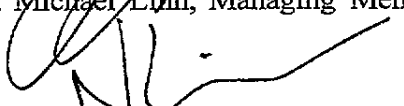

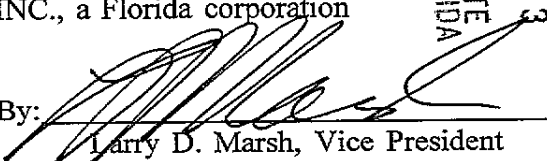
