Pursuant to Section 608.441 and Section 608.445 of the Florida Statutes, these articles of dissolution of Tucan Associates, L.L.C. set forth the following:

1. The name of the limited liability company is Tucan Associates, L.L.C. (the "Company").
2. The Articles of Organization were filed on August 30, 2000, and assigned document number L00000010460.
3. The effective date of the Company's dissolution is the date filed with the Florida Secretary of State..
4. As provided in the Company's operating agreement, an election by members of the Company collectively holding more than 50% of the percentage interests of all the members entitled to vote resulted in the dissolution of the Company pursuant to Section 608.441 of the Florida Statutes.
