**ARTICLES OF ORGANIZATION
OF
BAYSHORE PROPERTIES, LLC**

ARTICLE I: NAME

The name of this limited liability company is **BAYSHORE PROPERTIES, LLC** (hereinafter "Company"), whose mailing address and street address of the principal office of the limited liability company is **315 N.E. Third Ave., #200, Fort Lauderdale, Florida 33301.**

ARTICLE II: DURATION

This limited liability company shall remain in existence perpetually; and the effective date of commencement is hereby designated as of the date of filing of these Articles.

ARTICLE III: PURPOSE

ARTICLE V: INITIAL REGISTERED OFFICE AND AGENT

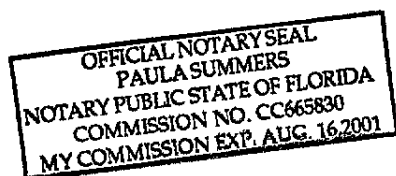


