ARTICLES OF ORGANIZATION  
OF  
SULTENFUSS COMPANY, L.L.C.

The undersigned hereby certifies that the members named herein have associated together for the purpose of becoming a Limited Liability Company under Chapter 608, Florida Statutes (the Florida Limited Liability Company Act), providing for the formation, rights, privileges and immunities of limited liability companies for profit and the following Articles of Organization are hereby adopted.

**ARTICLE I.**

NAME

The name of the limited liability company (the "Company") shall be SULTENFUSS COMPANY, L.L.C.

**ARTICLE I.**

MAILING AND STREET ADDRESS

**ARTICLE II.**

DURATION; EFFECTIVE DATE

This Company shall exist for a period commencing September 1, 2000, if these Articles are filed by the Department of State within five (5) business days after such date. If filed after such five (5) business days, the existence of this Company shall commence upon and as of the date on which these Articles of Organization are filed by the Department of State and shall continue, in either case, in perpetuity.

**ARTICLE IV.**

INITIAL REGISTERED OFFICE AND REGISTERED AGENT

**ARTICLE V.**

PURPOSE

It is the intent of the members that the Company be classified and taxed as a partnership for federal tax purposes.

ARTICLE XII.  
AMENDMENT

These Articles of Organization may be amended by a vote of members representing eighty percent (80%) or more of the ownership interests in the Company.
