

ARTICLES OF ORGANIZATION

OF

DIGIPOUR, LLC

The undersigned natural person, an organizer and a member of the company, hereby files these Articles of Organization to form a limited liability company under the Florida Limited Liability Company Act, more particularly, Chapter 608 Florida Statutes (1999) and any amendments thereto (the "Act").

ARTICLE 1. Name. The name of the limited liability company shall be DigiPour, LLC (the "Company").

ARTICLE 2. Duration. The period of the Company's duration shall be perpetual from the date of filing of these Articles of Organization with the Secretary of State of the State of Florida, until dissolved in accordance with the Act.

ARTICLE 3. Purpose. The Company shall have unlimited power to engage in and do any lawful act concerning any or all lawful businesses for which limited liability companies may be organized according to the laws of the State of Florida, including powers and purposes now and hereafter permitted by law to a limited liability company.


ARTICLE 4. Principal Office. The mailing address and the street address of the principal office of the Company shall be:
