**FIRST:** The name of this limited liability company shall be Wing Holdings, L.C. (the "Limited Liability Company").

**SECOND:** The period of duration for the Limited Liability Company shall be perpetual unless sooner dissolved in accordance with the laws of the State of Florida.

**THIRD:** The mailing and street address of the principal office of the Limited Liability Company shall be 14892 Paddock Drive, Wellington, Florida 33414-1028.

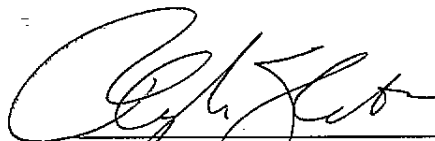
