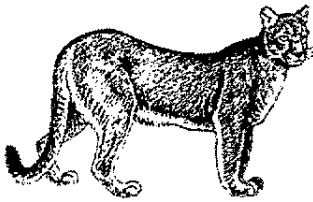



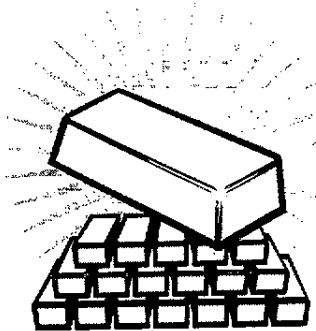

## Article 3 – Purpose


The limited liability company will provide e-business services or any business permitted under Florida Limited Liability Company Act.

**Article 8 – Management**


