Management

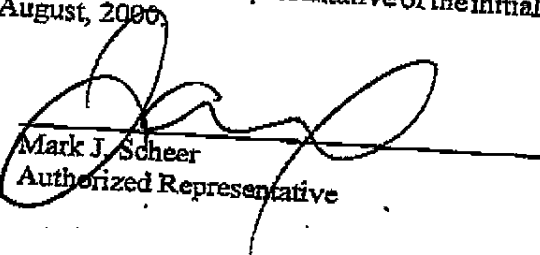
This company shall be managed by the Members in accordance with the Regulations and Operating Agreement of the Company.

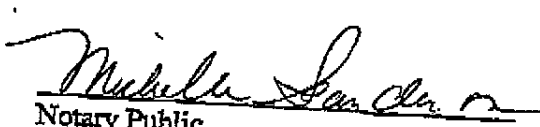

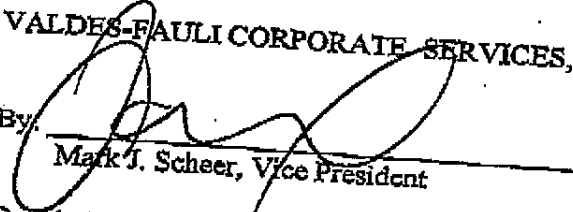
