# **ARTICLES OF ORGANIZATION**

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute 608 entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company:

Article l. Name. The name of this Company shall be: DAYTONA PERFORMANCE MARINE, LLC.

Article 2. Duration.
