**ARTICLES OF ORGANIZATION
OF
LBLSG, L.L.C.**

The undersigned members adopt the following Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act (the "Act").

**ARTICLE I
NAME OF COMPANY**

The name of the limited liability company is **LBLSG, L.L.C.** (the "Company").

**ARTICLE II
PERIOD OF DURATION**

The existence of the Company began on August 31, 2000, and will continue until August 31, 2099, unless it is terminated earlier in accordance with the provisions of the Company's Operating Agreement.

**ARTICLE III
REGISTERED OFFICE AND AGENT**

**ARTICLE IV
REQUIREMENTS FOR ADMISSION OF ADDITIONAL MEMBERS**

Additional persons may be admitted to the Company as members and membership interests may be created and issued to these persons upon the approval of the members entitled to vote.

**ARTICLE V
DISSOLUTION AND RIGHT TO CONTINUE BUSINESS**

The Company shall be dissolved upon the first to occur of the following:

- (a) The expiration of the term of the Company;
- (b) The unanimous written consent of all the Company's members;
- (c) The death, retirement, resignation, expulsion, dissolution or bankruptcy of a member, or any other event which terminates the membership of a member in the Company, unless within forty-five (45) days after such event at least one (1) of the remaining members agree in writing to continue the business of the Company.

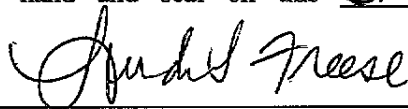

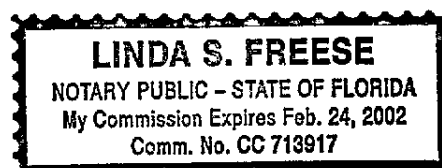
