**ARTICLES OF ORGANIZATION
OF

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

1. **NAME.**

The name of the Limited Liability Company is: **VILLAGES BOWLING ENTERPRISES, L.L.C.**

2. **ADDRESS.**

3. **PERIOD OF DURATION.**

The period of duration of the Limited Liability Company shall commence on the date of filing of these Articles of Organization and shall be perpetual, unless the Limited Liability Company is dissolved pursuant to provisions of the Florida Limited Liability Company Act or the Articles of Organization of the Limited Liability Company.

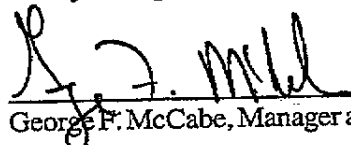

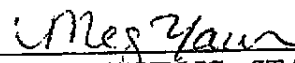
