## MEMBERSHIP



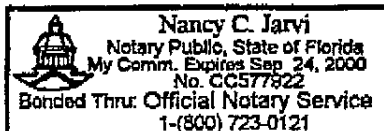
