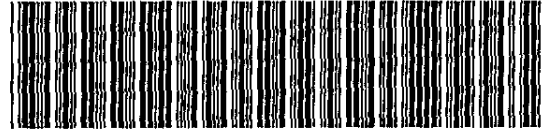

FIRST: This Article amends the Articles of organization of **Binary Logic Limited Liability Company**.

SECOND: The Articles of Organization were filed with the Florida Department of State on the 13th day of September, 2000.


THIRD: Article I of the Articles of Organization is hereby amended by deleting the existing Article I and replacing it with the following:
